Dear Valued Partners,

Out of an abundance of caution, Enjoy Life Foods is announcing the expansion of its June 30th voluntary recall, to add Best By dates for four items listed below to the list of recalled products. This recall is due to the potential presence of hard plastic pieces in the products.

This voluntary recall is not related to an allergen and no other Enjoy Life Products are affected by this voluntary recall. The company became aware of the additional items as a result of its internal investigation.

This letter covers **only** the products newly added to this recall. Please refer to our letter of June 30th for the original list of products covered by this recall.
